## <u>TechHire Grantees Develop Strategies to Increase Participant Success on</u> Certification Exams

Three TechHire grantees—Ivy Tech Community College in Indiana, Midlands Tech College in South Carolina, and Pellissippi State Community College in Tennessee, joined a Peer Consultancy call in July 2018 to exchange ideas, brainstorm challenges, and identify promising practices. Two key ideas emerged as particularly promising: *creating supports for test preparation* and *staying connected to students* to retake the exam for certification should they struggle in the first test.
