Why the Change from SCSEP's SPARQ to GPMS

The Grantee Performance Management System (GPMS) is the case management platform most universally used throughout DOL's Employment and Training Administration. In addition to increasing data consistency and enhancing security, shifting to GPMS will enable SCSEP Grantees to more effectively manage participant cases, business processes and performance data. Furthermore, as the primary source for entering, tracking and submitting program participant data that feeds into an organizations' Quarterly Performance Report (QPR), GPMS will simplify the transmission of SCSEP performance data to DOL's Workforce Integrated Performance System (WIPS). WIPS integrates shared program performance data points common to the US Departments of Labor and Education.

What You Need to Know During the GPMS Grantee Training/Before the Launch of GPMS

What You Need to Know After the Launch of GPMS

- The “Go Live” date for GPMS is July 1, 2022, when all new data/cases must ONLY be input into GPMS. All old data/cases must still be input into the legacy SPARQ system until September 1, 2022, when all SCSEP data/cases (both old and new) will have been migrated automatically to GPMS.
- Grantees will have access to SCSEP Intake and Eligibility GPMS functions on July 1st.
- The full availability and implementation of other GPMS functionality will be on-going as the GPMS development team will be in place for the continuous roll-out of enhancements to GPMS.
- Additional GPMS Training opportunities/schedules will be provided as necessary to coincide with the on-going rollout of enhancements to GPMS.
