### **Brett Vassey**

Brett Vassey is the sixth President & CEO of the VMA, representing Virginia's 5,800 manufacturing facilities employing over 230,000 Virginians. Vassey is also a founder and President & CEO of the Virginia Industry Foundation, which is a 501 (c) 3 non-profit research and education foundation, and the Virginia Craft Brewers Guild.

The VMA supports a government affairs division, a political action committee (VMAPAC) and a workforce solutions organization consisting of the nationally recognized Manufacturing Skills Institute and the three time national award winning Dream It Do It Virginia Network — an industry skills and career education resource for advanced technology occupations serving over 16,000 people annually. The VMA manages 11 member committees and councils; a statewide professional development events program; a business services program, and web-based news resources. The VMA and its affiliates also host a number of industry promotion activities, including National MFG Day, Virginia Craft Beer Month, the Virginia Craft Brewers Fest and the Virginia Craft Beer Cup. The VMA is the state association group for the National Association of Manufacturers (NAM), and is the state affiliate for the American Chemistry Council (ACC) and the Consumer Energy Alliance (CEA).

Vassey serves on numerous Federal, State and business Boards and Councils including the NAM State Association Group, US Global Leadership Coalition's Virginia Advisory Committee, the Vice Chairman of the Consumer Energy Alliance Board of Directors, the Virginia Manufacturing Development Commission, the Executive Committee and Performance & Accountability Committee Chair of the Virginia Board of Workforce Development; the Eastern Virginia Groundwater Management Advisory Committee; the

Governor's Climate Change & Resiliency Commission; and the GO Virginia advisory committee. In previous years, Vassey has served on the Southern Governors' Association's Southern Regional Manufacturing Consortium, the U.S. Department of Commerce's Virginia District Export Council, the Coalition for a Democratic Workplace Steering Committee; VirginiaFIRST Foundation Board, the Virginia Rural Jobs Commission, Governor Bob McDonnell's Jobs and Economic Development Commission, the Governor McDonnell Transition Team, the Virginia Attorney General's Regulatory Reform Task Force, the Virginia Commission on Youth's Career and Technical Education Subcommittee, VA Governor's Workforce Development Strategic Plan Steering Committee, the Virginia Public Access Project Board; the Greater Richmond Chamber's Workforce One Leadership Council, the Chesterfield County Comprehensive Plan Steering Committee, and as Chairman of Business Retention and Expansion International's (BREI) Marketing and Membership Committee. Vassey is a member of the NAM, the Conference of State Manufacturers Associations and the American Society of Association Executives. Vassey has been published numerous times in regional, state and national publications, including Politico.

Prior to the VMA, Vassey held positions in public policy, economic development and college administration in the Commonwealth of Virginia, Kansas and Missouri. Vassey has a Master of Public Administration from Virginia Tech's Center for Public Administration and Policy. He graduated in the top 10% of his class and is a member of the National Honor Society for Public Affairs and Administration - Pi Alpha Alpha. He was a 2005 Governor's Fellow for Virginia Governor George Allen. Vassey has a Bachelor of Arts in Political Science from the University of Kansas. Mr. Vassey was selected for the 2015 University of Kansas Who's Who of Distinguished Alumni and 2006-2007edition of the *National Register's Who's Who in Executives and Professionals*. Vassey is also a guest lecturer at the UVa Sorensen Institute for Political Leadership. Vassey is married and his wife is an executive with a legal publisher. They have one child and live in Chesterfield County, Virginia.

### **Thomas Penny**



Thomas Penny, a DC area native who has spent 24 years managing hotels in the DC region, is the General Manager of the Courtyard Marriott Convention Center. Under his leadership, the Courtyard by Marriott Convention Center has consistently ranked in the top Courtyards in the world in RevPAR (revenue per available room).

Prior to joining the Courtyard, Thomas was the Assistant General Manager of the 532-room hotel in Southwest, DC. While serving in this capacity, Thomas

played an instrumental role in the hotel ranking in the top ten within the brand in RevPAR, achieving multiple brand Quality Excellence awards. Upon being promoted to the position of F&B Director at this hotel at the age of 25 years old, Thomas was at the time the youngest and only African-American member of InterContinental Hotel's Group Food and Beverage Council with responsibility for establishing and evaluating food and beverage standards for one of IHG's core brands worldwide.

Thomas' drive for the hotel industry and concern for the community was fanned to higher flame after his only brother was killed in a car accident, while out celebrating his 18th birthday. Thomas believes in

the timeless quote, "Adversity doesn't build character, it reveals it." After his start in the hotel industry as a dishwasher at the age of 17 years old and moving quickly through the ranks, Thomas believes that you learn the next job shortly after mastering the one you have. Thomas is presently 1 of the 5 African-American hotel General Managers out of 148 hotels in Washington, DC.

In January of 2014, Thomas became the second African-American to ever serve as Chair of the Board of the Hotel Association of Washington, DC. He is the Co-Chair of DC NAF Hospitality Executive Advisory Board—a body of hospitality executives charged with exposing high school students to the hospitality business from operations to ownership.

He serves on the DC Public Education Fund Board where the Board is working to raise funds to support the innovative and transformational work of DC Public Schools. With his passion for ensuring underserved District residents are able to work, earn a living wage and provide for their families, Thomas is a member of the Mayor's Workforce Investment Council (WIC). In addition, he serves on the Board of SOME (So Others May Eat), DC Central Kitchen, Covenant House DC, Raise DC and co-chairs Prince George's Community College's Hospitality Executive Advisory Board.

Thomas has been the recipient of numerous awards. Some include the National Society of Minorities in Hospitality (NSMH) Howard University Chapter's (2008) Legacy of Achievement Award, (2009) The Network Journal's Top 40 Under Forty Award, (2010) Washington Business Journal's Minority Business Leader Award, (2010) 100 Black Men of Greater Washington's Legacy Award for Mentoring, (2011) Visitors Service Center's Charles A. Horsky Civic Leadership Award, (2014) Courtyard Marriott National Academy Foundation Partnership Award (2015) Court Services Office of Supervision (CSOSA) Making a Difference Award, (2016) DC Morehouse Alumni Chapter's E.B. Williams Excellence in Business Award, the (2016) American Hotel and Lodging Association Education Institute's "Lamp of Knowledge Award" for Outstanding Workforce Partner and the (2016) Bridges Marriott Foundation Leadership Award.

Thomas is the proud father of two beautiful children. Thomas is a voracious reader of history and leadership books and is presently working on finishing his own book titled, "Hope, Help and Hospitality." This book chronicles his life story and experiences within the hospitality industry.
