**DOL Posts Blog GetMyFuture.org: Essential Youth Resources, Now.** The Acting Assistant Secretary for the Employment and Training Administration shared the launch of GetMyFuture.org, a mobile-friendly web portal connecting young adults to career, education and job search resources. Think of it as your doorway to the hall of doors that stretch out before you as you begin your career. The site offers online tools and information for young adults age 16 to 24, and provides special resources for those experiencing barriers to success such as involvement in foster care, addiction, homelessness, teen parenting, or a lack of financial, family or community resources.



# **Success Story**



### Los Angeles Conservation Corps YouthBuild

Sam (not his real name) came to the Los Angeles Conservation Corps YouthBuild as a high school dropout. He was raised by a single parent who worked long hours to support him and his three other siblings. At the age of 12, Sam decided to join a street gang, leading to his dropping out of school. As a gang member, he was arrested three times for fighting and possession of weapons. At this point, his mother pushed him to join the YouthBuild program

because she did not want her son either back in jail or buried in a grave.

Sam decided to make a change in his life and enrolled in the LA Corps YouthBuild program. He stopped hanging out with the gang and started focusing on attaining a high school diploma. He enjoyed the new environment because he felt as if he had been given a second chance to make a positive difference. Through the program, he attained his high school diploma and took a number of environmental trainings, through which he was certified in Asbestos, HAZWOPER, Lead Abatement, OSHA 10, Refinery Safety Overview, and First Aid/CPR. After completing the trainings, he was offered an opportunity to join the Southern California Heat & Frost Insulators Joint Apprenticeship union as a pre-apprentice. He is currently enjoying his0 work as an oil refinery insulator and is looking forward to more opportunities in the environmental field.

The paper also suggests complementing these two initiatives by having outside groups provide the individualized mentoring students need to develop plans that they are confident can be realized, as well as the support needed to overcome obstacles. read more ...

On April 26, The Hamilton Project hosted a policy forum entitled: **Leveling the Playing Field – Policy Options to Improve Postsecondary Education and Career Outcomes**. The forum explored several key challenges currently facing the United States in both K–12 and postsecondary education.
