ETA Announces 2017 WIOA National Convenings. In the spring of 2017, the U.S. Department of Labor, in collaboration with its Education and Health and Human Services partners, will host three national convenings. DOL Seeks Comments on the Performance Partnership Pilots (P-3) for Disconnected Youth Program National Evaluation. The Department of Labor (DOL) is submitting the information collection request (ICR) proposal titled, "Performance Partnership Pilots for Disconnected Youth Program National Evaluation," to the Office of Management and Budget (OMB) for review and approval for use in accordance with the Paperwork Reduction Act (PRA) of 1995. Comments due: March 23. read more...

USDA Issues Policy Clarifications for Administering the Supplemental Nutrition Assistance Program (SNAP) Employment and Training (E&T) Programs. During management evaluation reviews and technical assistance efforts, the Food and Nutrition Service (FNS) within the Department of Agriculture had identified many compliance issues in States that operate mandatory E&T programs that caused concern. A memorandum prepared in mid-January 2017 identifies and clarifies several statutory and regulatory requirements that State agencies operating mandatory E&T programs must implement to ensure adequate protections for SNAP applicants and recipients as well as proper administration of the program. <u>read more...</u>

Citi Foundation's Pathways to Progress Expands Globally With a Three-Year \$100 Million Commitment to Prepare 500,000 Young People for Today's Competitive Job Market. Citi announced a global expansion of the <u>Pathways to Progress</u> initiative led by a Citi Foundation investment of \$100 million to connect 500,000 young people, ages 16-24, to training and jobs over the next three years. This is the largest philanthropic commitment in the Citi Foundation's history. *Pathways* launched in 2014 with a \$50 million effort that helped more than 100,000 young people across 10 U.S. cities become career-ready through first jobs, internships, and leadership and entrepreneurship training. <u>read more...</u>

IMLS Seeks Comment on Maker/STEM Education Support for 21st Century Community Learning Centers Program Evaluation. The Institute of Museum and Library Services' (IMLS), National Foundation for the Arts and the Humanities published a thirty-day notice in the February 13 FEDERAL REGISTER, requesting comments on a proposed survey to collect information to monitor the use, expectations of and satisfaction with the quality of Maker/STEM program implementation at 21st Century Community Learning Centers (21st CCLC). IMLS will use qualitative and quantitative data collection via a mixed methods approach. Data will be collected through activities such as online and/or paper and pencil surveys, phone interviews, and in-person interviews with the "target population" of museum/science center staff, 21st CCLC staff, and youth participants involved in the STEM/Making programs at targeted 21st CCLC sites. The evaluation is intended to provide insight for future changes, programmatic improvements, and learning at all levels of the program. Deadline: April 10, 2017. read more...





Success Story

The Workplace-CT

The Workplace grantee in Bridgeport, Connecticut, currently has two DOL REO grants and also had grants in the past. One of their best practices is how they have engaged their legal services partners to support youth retention in the program and offer support in dealing with existing legal issues for themselves and their

families. A unique product of this grantee partnership is the recent development and dissemination of an app for youth to connect to legal services via a mobile platform: **<u>ErasURecord.ctlegal.org</u>**. This app refers youth to direct offices and agencies that provide expungement, diversion and other services to youth with issues that may be barriers to program and employment success. They are currently in the process of expanding the dissemination of the app to the juvenile services partners, youth services providers and educational and workforce organizations. CT Workplace has partnered for many years as part of several DOL grants, with CT Legal Services as they provide a broad range of legal services to youth. The Department of Education's Office of Postsecondary Education is accepting applications for The Upward Bound (UB) Program. The UB Program is one of the seven programs known as the Federal TRIO Programs. It also supports projects designed to provide students with the skills and motivation necessary to complete a program of secondary education and to enter into, and succeed in, a program of postsecondary education. There are three types of grants under the UB Program: UB; Veterans UB; and UB Math and Science (UBMS) grants. **Deadline: March 22.** read more...

NTTAC Announces the Launch of a New Community of Practice Website on Youth Pathways to Postsecondary and Employment. The National Training and Technical Assistance Centers has launched the Youth Pathways to Postsecondary and Employment site. This website is designed to serve as a platform for a cross-boundary Community of Practice for professionals who share a passion and a vision for building pathways for students and youth with disabilities to postsecondary and employment. Access to this new website and the resources posted does not require a login or password, however to join the Community of Practice, you will need to request membership.

Vulnerable Youth: Federal Mentoring Programs and Issue. This report released by Congressional Research Services includes an overview of the purpose of mentoring, including a brief discussion on research of structured mentoring programs. It also describes the evolution of federal policies on mentoring since the early 1990s. <u>read more ...</u>

New Data on Postsecondary Enrollment, Finance, Academic Libraries, and Employees at Postsecondary Institutions. This report released by the National Center for Education Statistics includes fully edited and imputed data from the Integrated Postsecondary Education Data System (IPEDS) spring 2016 data collection, which included four survey components: Enrollment for fall 2015; Finance for fiscal year 2015; data on employees in postsecondary education for Fall 2015; and data for Academic Libraries for fiscal year 2015. <u>read more...</u>

Personal Financial Literacy: The New Social Studies Course for Texas. This course released by the Federal Reserve Bank of Dallas is offered in every high school across Texas. This site contains a suggested scope and sequence for the course that is organized by the strands of the Texas Essential Knowledge and Skills (TEKS) for the course. The materials are from various Federal Reserve banks, nonprofit organizations and state and national government agencies. read more...

Positive Youth Development Measurement Toolkit. This toolkit released by Making Cents International provides implementers of youth programming a variety of references, resources, and tools on how to use a positive youth development (PYD) approach for evaluating youthfocused programming. A PYD approach to evaluation will measure whether youth are positively engaged in and benefiting from investments that ultimately empower them to develop in healthy and positive ways so that they can contribute to the development of their communities. <u>read more...</u>

Navigate: Exploring College and Careers. This resource released by the Federal Reserve Bank of Dallas provides an introduction to the investigation of careers and college and is designed for 7th through 9th grade students.
