ETA Announces Release of Change to YouthBuild Training and Employment Guidance Letter! The Employment and Training Administration (ETA) released Change 1 to Training and Employment Guidance Letter (TEGL) 35-12: Clarification on Definition and Guidance of Allowable Construction Credentials for YouthBuild Programs. It provides further clarification of the ETA definition of the term credential for national YouthBuild program grantees as well as additional guidance on commonly used construction credentials for YouthBuild participants. NIOSH and Workforce Tulsa Partner to Promote Workplace Safety and Health Among Young, Temporary Workers. The National Institute for Occupational Safety and Health (NIOSH) and Workforce Tulsa are pleased to announce a collaboration to develop and pilot test a new training program, Developing Work Safety Skills, to promote workplace safety and health practices among young adults seeking career services and temporary employment opportunities through Workforce Tulsa.

<u>Verizon Innovative Learning Brings New Tech Program to Girls in Rural Communities</u>. This summer, Verizon Innovative Learning launches its first program addressing the need for more girls, especially those in rural America, to be prepared for the science, technology, engineering and math careers of the future. The three-week summer learning experience will be piloted at five community colleges in rural areas across Iowa, Virginia and Tennessee in partnership with the National Association for Community College Entrepreneurship. The program will expose 250 middle school girls to the fundamentals of augmented reality, coding, 3D design, entrepreneurship and design thinking principles, as well as to female mentors. Leveraging an augmented reality interface and app, students will create a culminating project that identifies – and solves – a community problem that aligns with the United Nations' Sustainable Development Goals (SDGs). Focus areas of the SDGs include poverty reduction, quality education, good health and well-being, climate action, peace and justice or gender equality.

<u>Kentucky Initiative Wants College, K–12 Students to Reach for Cloud Careers</u>. In Kentucky, both K–12 and college students will soon have access to blended learning, online learning, internships, apprenticeships, jobs and other opportunities in the cloud computing field. The <u>Kentucky Department of Education</u> and additional state parties, along with <u>Amazon Web</u> <u>Services</u> and the nonprofit education organization <u>Project Lead the Way</u>, have all joined forces in an effort to build a cloud-enabled workforce.

HHS Seeks Public Comment on Information Collection for Transitional Aged Youth. The U.S. Department of Health and Human Services' Substance Abuse and Mental Health Services Administration has published a request in the July 14 FEDERAL REGISTER seeking comments on the Biannual Infrastructure Development Measures for State Adolescent and Transitional Aged Youth Treatment Enhancement and Dissemination Implementation (SYT-I) and Adolescent and Transitional Aged Youth Treatment Implementation (YT-I) Program. The purpose of this program is to provide funding to States/Territories/Tribes to improve treatment for adolescents and transitional age youth through the development of a learning laboratory with collaborating local community-based treatment provider sites. Through the shared experience between the State/Territory/Tribe and the local community-based treatment provider sites, an evidence-based practice will be implemented, youth and families will be provided services, and a feedback loop will be developed to enable the State/Territory/Tribe and the sites to identify barriers and test solutions through a services component operating in real time. Success Story

Summer Job Youth Grant in Lehigh Valley, PA (photograph by LCTI)



Twenty Rising Seniors from the Lehigh Valley in Pennsylvania took part in the Summer Job Youth Grant program offered by the Lehigh Valley Workforce Development Board to sharpen their employability skills. Students spent seven days learning how to be good employees through classroom training prior to setting out to work at their local schools for the summer. The training was done at Lehigh Career & Technical Institute and included the soft skills that employers are looking for in an employee. The soft skills learned included: teamwork, respect, interpersonal skills, working attitudes, computer and cell phone etiquette, the difference between their personal life and their work life, conflict management, interview and

resume skills, and financial literacy to name a few. Then it was on to workplace safety; learning about OSHA, ergonomics, good lifting techniques, housekeeping, ladder safety, lock-out/tag-out, hazard communication, electrical safety, temperature extremes, and how to use Personal Protective Equipment. As a requirement of the program, the students had the privilege of touring Nestle Waters manufacturing plant in Breiningsville, the Workforce Development Board in Allentown, Lehigh Carbon Community College and the Electro-mechanical program at Lehigh Career & Technical Institute. The program was capped off with a certificate ceremony. Employed students will be mentored by skilled workers at the school and their progress will be monitored throughout their employment to identify growth and career readiness.
