WIPS Training and SCSEP Grantee Orientation

When is the WIPS Training webinar?

The Workforce Integrated Performance System (WIPS) webinar will take place on **Thursday, January 23, 2025, from 2:00 PM to 3:30 PM ET**. Toni Wilson, Unit Chief, Older Workers Unit, and Ali Slaughter, Workforce Development Specialist, will serve as the moderators/presenters for this virtual event. What will be covered in the WIPS Training?

This webinar will offer SCSEP grantees a comprehensive overview of the WIPS system and the reporting process. It will include a step-by-step demonstration, guiding grantees through the entire submission process – from generating reports in GPMS to reviewing and submitting them in WIPS. Additionally, the session will cover how to investigate and solve errors, and guide how to request support for WIPS submissions. This training is intended for all Grantee Administrators in SCSEP GPMS who have permission to submit and certify QPR reports in WIPS.

When is the SCSEP Orientation?
