

The Office of Workforce Investment (OWI), in collaboration with the US Department of Agriculture (USDA), Appalachian Regional Commission (ARC), and the First Tennessee Development District and its partners, presented on how opioid addiction has impacted the rural workforce and what resources are available to support recovery through the workforce system.

Kellie Kubena and Carol Wetuski from the US Department of Agriculture presented on the USDA programs that support rural communities with substance use, workforce development, and economic development. The team also provided an overview of the Rural Workforce Innovation Network (RWIN) which is a forum for public and private partners to help increase access to workforce opportunities across rural America. The Appalachian Regional Commission's Lauren Wood provided insight on the Investments Supporting Partnerships In Recovery Ecosystems (INSPIRE) Initiative that addresses the substance use disorder (SUD) crisis across Appalachia by creating or expanding a recovery ecosystem that will lead to workforce entry or re-entry.

Last, Lottie Ryans from the First Tennessee Development District (FTDD), a Department of Labor Workforce Opportunities for Rural Communities (WORC) grantee, and their partner organizations spoke from a local viewpoint on the impact of substance use in their rural communities and how FTDD, through collaborative efforts with their many partners, support individuals in recovery while in the workplace.
